

Prescribing with iAssist vs CoAssist Pharmacy

In addition to traditional fax, Dompé offers 2 options for digital prescription of OXERVATE and enrollment into Dompé CONNECT to Care (DC2C): iAssist and CoAssist Pharmacy. Since both have slightly different requirements, it's important to consider a few things before choosing the right path for your office:

- Consider the preferences of your office:
 - Are electronic medical records/electronic health records (EMRs/EHRs) part of your practice workflow?
 If yes, CoAssist Pharmacy could be the option for your practice
- Does your practice have familiarity with digital portals? If yes, iAssist could be the option for your practice
- · Confirm what patient information will be needed for prescribing through iAssist or CoAssist Pharmacy

Field Access Managers (FAMs)

The FAM educates practices on DC2C services and provides education on payer trends and changes.

Please ask your Key Account Manager (KAM) for your FAM's contact information.

Patient Access Managers (PAMs)

The PAM monitors patient cases and provides case management support as needed.

CoAssist Pharmacy

CoAssist Pharmacy is an online platform that automates patient access from your practice's existing EMR/EHR systems to prescribe OXERVATE® and enroll eligible patients into Dompé CONNECT to Care.

CoAssist Pharmacy features include:

- Proactive capture of patient consent through text message
- Real-time PA submission with decisions returned in minutes*
- eBenefits Verification (eBV), including if PA is required, in <15 seconds

*PA decisions can be returned in minutes to hours depending on payer/pharmacy benefit manager (PBM) electronic capabilities.

iAssist

iAssist is an online portal that provides HCPs with a streamlined process to prescribe OXERVATE, submit an electronic PA, and enroll patients in Dompé CONNECT to Care.

iAssist can help you:

- Capture all patient enrollments from your practice in one platform and dashboard
- Reduce PA turnaround times by uploading patient insurance cards, medical history, and letters of necessity when on the iAssist platform
- Digitally capture patient consent and prescriber signature
- · Access benefit verifications and patient financial assistance programs where appropriate
